To provide a caring, Christian ethos for the school, which inspires and excites a shared enthusiasm for life and learning.

At Ivington CE Primary and Pre-school, through our strong Christian ethos and focus on nine important Christian values, we are committed to providing a deeply nourishing, spiritual, ambitious, and broad curriculum.

Our motto, 'Reaching together' underpins our belief in equality of opportunity for all, where we actively endeavour to promote understanding and appreciation of our diverse society and give each child a special place in the world where they feel valued, essential to our community and equipped with the necessary skills to make a positive contribution.

We perceive our role to be opening a 'Window on the World', through which our pupils are actively encouraged to develop respect for the beliefs and cultures which enrich their everyday lives and encourage others to do likewise.

We strive to eliminate inequality through our deep Christian ethos of respect and understanding of all groups in society, which ensures that everyone at Ivington will be treated fairly despite his or her creed, colour, disability, or gender.

The health, safety, and welfare of all the people who work or learn at our school are therefore of fundamental importance. We aim to provide a safe, secure, and pleasant working environment for everyone. The governing body, along with the LA, takes responsibility for protecting the health, safety and welfare of all children and members of staff.

#### 1. Aims

This policy aims to:

- > Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- > Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- > Clarify our expectations for school uniform

# 2. Ivington CE Primary and Pre-school's legal duties under the Equality Act 2010

The <u>Equality Act 2010</u> prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment.

To avoid discrimination, Ivington CE Primary and Pre-school will:

- > Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- > Make sure that our uniform costs the same for all pupils
- > Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back)
- > Allow all pupils to style their hair in the way that is appropriate for school yet makes them feel most comfortable
- > Allow pupils to request changes to swimwear for religious reasons
- > Allow pupils to wear headscarves and other religious or cultural symbols
- > Allow for adaptations to our policy on the grounds of equality by asking pupils or their parents to get in touch with the Headteacher who can answer questions about the policy and respond to any requests

# 3. Limiting the cost of school uniform

Ivington CE Primary and Pre-school has a duty to make sure that the uniform we require is affordable, in line with statutory <u>guidance</u> from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items, limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- > Is available at a reasonable cost
- > Provides the best value for money for parents/carers

We will do this by:

- > Carefully considering whether any items with distinctive characteristics are necessary
- > Limiting any items with distinctive characteristics where possible

- > Limiting items with distinctive characteristics to low-cost or long-lasting items, such as book bags
- > Considering cheaper alternatives to school-branded items, such as logos that can be ironed on, as long as this doesn't compromise quality and durability
- > Avoiding specific requirements for items pupils could wear on non-school days, such as coats, bags and shoes
- > Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveler
- > Avoiding different uniform requirements for different year/class/house groups
- > Avoiding different uniform requirements for extra-curricular activities
- > Considering alternative methods for signaling differences in groups for interschool competitions, such as creating posters or labels
- > Making sure that arrangements are in place for parents to acquire second-hand uniform items
- > Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- > Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

# 4. Expectations for school uniform

#### 4.1 Our uniform

#### School uniform:

Navy sweatshirt or cardigan - plain or with school logo

Red polo shirt – plain or with school logo

Dark Grey trousers or skirt

Red gingham summer dress

Plain, suitable coloured socks or tights - black/grey/white Sensible, dark coloured shoes

#### PE Kit:

Red t-shirt—plain or with logo

Black shorts

Jogging trousers for outdoor PE in the winter

Navy Hoody for outdoor PE in the winter Trainers or black pumps

#### **Swimming**

Swimming costume/trunks Towel

Swimming hat Googles (if required)

**Forest School** – essential that they are old clothes or clothes that parents/carers do not mind getting dirty. Wellington boots or walking boots

Long trousers Long sleeved top

Layers of clothing appropriate to the weather and season Waterproof top and trousers or a waterproof 'all in one' Hat – for sun or warmth

Gloves – preferably waterproof

#### **Additional items:**

Coats – warm, hooded and waterproof

Book bags, an optional but recommended purchase, can be purchased from the school office.

PE bags, an optional but recommended purchase, can be purchased from the school office.

Water bottle – all children should bring a water bottle into school every day, this can be refilled by children whenever necessary during the day. Water bottles must be labelled with the pupil's name.

# 4.2 Where to purchase it

Club Sport in Leominster sells items of the uniform that has the logo on: sweatshirts, cardigans, polo shirts, T-shirts, hoodies and coats.

Ivington CE Primary and Pre-school have a selection of pre-loved uniform with items available through the school offices or the termly uniform sales.

# 5. Expectations for our school community

### 5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- > On the school premises
- > Travelling to and from school
- > At out-of-school events, on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact the Headteacher, if they want to request an amendment to the uniform policy in relation to their protected characteristics.

#### 5.2 Parents and carers

Parents and carers are expected to make sure that their child has the correct uniform and PE kit, and that every item is:

- > Clean
- > Clearly labelled with the child's

name > In good condition

Parents are also expected to contact the, if they want to request an amendment to the uniform policy in relation to:

> Their child's protected

characteristics > The cost of the

uniform

Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner.

Disputes about the cost of the school uniform will be:

- > Resolved locally
- > Dealt with in accordance with our school's complaints policy

Ivington CE Primary and Pre-school will work closely with parents to arrive at a mutually acceptable outcome.

#### 5.3 Staff

Staff will closely monitor pupils to make sure that they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the Headteacher if the situation does not improve.

Ongoing breaches of our uniform policy will be dealt with fairly by the Headteacher.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

#### 5.4 Governors

The Governing Board will review this policy and make sure that it:

- > Is appropriate for the context of Ivington CE Primary and Pre-school
- > Is implemented fairly across Ivington CE Primary and Pre-school
- > Takes into account the views of parents and pupils
- > Offers a uniform that is appropriate, practical and safe for all pupils

The Governing Board will also make sure that the uniform supplier arrangements for Ivington CE Primary and Pre-school give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by re- tendering contracts at least every 5 years.

#### 6. Monitoring arrangements

This policy will be reviewed annually by the Governing Body.
